Full payment is to be made on the date storage begins. An additional fee of \$30.00 will be charged for any returned checks. Payment must then be made in cash or certified funds.

The Owen County Fair Association does not provide security, however, our buildings will remained locked during storage.
All batteries must be removed from vehicles prior to storing.

The Owen County Fair Association does not take custody or control of the property during rental time nor does the Owen County Fair Association provide any clean-up services or other services.

You may pick up your property the 1st Saturday in April between the hours of **9:00 am to 11:00 am**. Doors will be locked before opening and after closing of specified times. **NO OTHER NOTICE OF PICK UP TIME WILL BE MAILED OR GIVEN.**

Property will be removed from rental space and remain outside after the above mentioned pick up date at owner's risk.

A \$10.00 per day fee will be charged each day property remains on the fairgrounds after stated pick up date.

The owner shall be responsible for or carry insurance for any damages or loss by theft, fire, vandalism, malicious mischief, wind storm, hail, lightning, flood, and other physical damages which may occur on premises during time property is in rental space on said premises.

The Owen County Fair Association assumes no liability for loss to property or of any claim for personal injury including death. The owner of property using rental space hereby releases the Owen County Fair Association, its component members and their successors from liability of any character and agrees to indemnify said parties from any and all liability by reason of injury to property and/or persons including death which may occur within or upon the premises herein described in any manner connected with use thereof by owner.

In signing this agreement I expressly declare and represent that all detachable items and accessories have been removed prior to presenting the above described property for rental, and further, I expressly understand that by this agreement I am releasing the Owen County Fair Association, their agents, successor, and assigns from any liability for loss through theft of all detachable items and accessories present on the vehicle at the time it was presented for rental space.
